The consequences of the said designation are that

- (1) the demolition of certain buildings is brought within listed building control, under section 277A
- (2) any person proposing to do work on trees in the area is required to give 6 weeks prior notification to the local planning authority of his intention, unless the trees are already protected by a tree preservation Order, in which case an application for consent will be required section 61A

- (3) the authority come under a duty under section 277B to formulate and publish proposals for the preservation and enhancement of the area
- (4) planning applications for development which would, in the opinion of the local planning authority, affect the character or appearance of the conservation area must be given publicity under section 28, and representations received in consequence taken into account in determining the application (section 29(4))
