

9. The carrier of imported animals must notify the person in charge of the reception centre of the proposed time of landing, the number of animals and their description.

10. Animals intended for breeding or meat production originating from brucellosis free herds will be consigned from the reception centre, under a movement licence, direct to a named destination premises, where the animals must be isolated for a period of at least 10 weeks until a brucellosis serum agglutination test has been carried out with negative results.

11. All steers are exempt from brucellosis testing requirements.
