*The County of Humberside (Glanford Borough) (Bigby Street, Brigg) (Prohibition and Restriction of Waiting) Order 1985.*

##### *Traffic Regulation Orders, Bolton*

Notice is hereby given that on 2nd December 1985, the Greater Manchester Council made Orders under the sections indicated of the Road Traffic Regulation Act 1984. The Orders and their effects are as follows:

*The Greater Manchester County (Victoria Square North and South) (Disabled Persons Parking Places) (County) Order 1984, Sections 32 and 35.*

This Order authorises the use of the following parts of road as free parking places for disabled person's vehicles displaying a disabled person's badge at any time on any day:

*Victoria Square North*, south side, from 12 metres west of the easterly end of the Square for a distance of 13 metres in a westerly direction.

*Victoria Square South*, east side, from 5 metres south of the northerly end of the Square to 17 metres south of the northerly end of the Square.

*The Greater Manchester County (Victoria Square South, Bolton) (Prohibition of Waiting) (County) Order 1984, Sections 1 and 2.*

To prohibit waiting at any time on:

*Victoria Square South*, north side, from its easterly end for a distance of 20 metres in a westerly direction:

*Victoria Square South*, east end, from its northerly end for a distance of 5 metres in a southerly direction.

*The Greater Manchester County (Great Moor Street, Bolton) (Prohibition of Waiting) (County) Order 1985, Sections 1 and 2.*

To prohibit waiting at any time on:

*Great Moor Street*, south-east side, from 15 metres south-west of Blackhorse Street to 15 metres north-east of Ormrod Street.

The Orders, which come into operation on 9th December 1985, contain exemptions for the purposes of boarding or alighting, loading or unloading, funerals, building operations or work on or under the roads.

Copies of the Orders and plans showing the roads to which they relate, may be inspected between 9 a.m. and 4.30 p.m. on Monday to Friday at the County Legal Office, County Hall, Piccadilly Gardens, Manchester, or at the Council Solicitor's Office, Bolton Borough Council, Town Hall, Bolton.

Any person who wishes to question the validity of any Order, or of any provision contained in them on the grounds that they are not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or of any Instrument made under it has not been complied with in relation to any Order, may, within 6 weeks from 2nd December 1985, apply to the High Court for this purpose.
