The South Yorkshire County Council (Various Roads Sheffield) (Area No. 6) (Amendment No. 29) Order 1985

Notice is hereby given that on 29th November 1985, the South Yorkshire County Council made an Order under the provisions of the Road Traffic Regulation Act 1984.

The effect of the Order which will come into operation on 15th December 1985, will be to prohibit waiting by vehicles between the hours of 8 a.m. and 6.30 p.m. Monday to Saturday inclusive in that length of Miller Road at Sheffield which extends from a point 22 metres south-east of its junction with Abbeydale Road to its termination including the turning head.

Exceptions to the Order will permit waiting for the purpose of picking up and setting down passengers, loading and unloading goods, in connection with building, industrial or demolition operations, the removal of obstructions to traffic, the maintenance of the roads and the services therein, in pursuance of statutory powers or duties and for the collection and delivery of postal packets. The usual exceptions for disabled persons' vehicles are also included in the Order.

SOUTH YORKSHIRE COUNTY COUNCIL

The South Yorkshire County Council (Various Roads, Warmsworth and Edlington) (Traffic Regulation Consolidation) Order 1980 (Amendment No. 2) Order 1985.

Notice is hereby given that on 6th December 1985, the South Yorkshire County Council made an Order under the provisions of the Road Traffic Regulation Act 1984.

The effect of the Order which will come into operation on 16th December 1985 is to:

- (i) prohibit the waiting of vehicles at any time on the sides of road specified in Part I of the Schedule to this notice;
- (ii) to prohibit the waiting of vehicles between 8 a.m. and 6 p.m. Mondays to Saturdays inclusive on the side of road specified in Part II of the Schedule to this notice; and

PART I

Sides of road at Edlington in the Metropolitan District of Doncaster

No Waiting at any time

Edlington Lane

West side:

(v) from a point 15 metres south-west of the south-western kerb-line of Cross Street north-eastwards to its junction with the northern kerb-line of Bungalow Road.

East side:

(iii) from a point 15 metres south-west of the south-western kerb-line of Cross Street north-eastwards to a point 37 metres north-east of the north-eastern kerb-line of Cross Street.

Cross Street, both sides, from its junction with Edlington Lane south-eastwards for a distance of 15 metres.

PART II

No waiting between 8 a.m. and 6 p.m. Monday to Saturday inclusive

Edlington Lane

South-east side:

(i) from a point 78 metres north-east of the north-eastern kerb-line of Cross Street north-eastwards to a point 165 metres north-east of the north-eastern kerb-line of Main Avenue.
