GREATER MANCHESTER COUNTY COUNCIL

The Greater Manchester County (A6 Manchester Road, Swinton) (Prohibition of Waiting) (County) Order 1985

Notice is hereby given that the Greater Manchester County Council propose to make an Order under sections 1 and 2 of the Road Traffic Regulation Act 1984, the effect of which will be to prohibit waiting at any time on the north side of Manchester Road, Swinton from the easterly gable of number 243 Manchester Road in an easterly direction for 47 metres.

The proposed Order contains exemptions to permit waiting for the purposes of boarding or alighting, loading and unloading, funerals, building operations or work on or under the length of road.
