NOTICE OF SEIZURE UNDER THE CUSTOMS AND EXCISE MANAGEMENT ACT 1979

11th December 1985

Pursuant to section 139 (6) of the Customs and Excise Management Act 1979, and paragraph 1 of Schedule 3 thereto, the Commissioners of Customs and Excise hereby give notice that by virtue of the powers contained in the Customs and Excise Acts.

A DAF box-sided truck, Registration number 66-43-2B has been seized as liable to forfeiture by force of the following provisions namely:

(1) Sections 49 (1) (b) and 141 (1) of the Customs and

Excise Management Act 1979

In that on or about the 11th day of July 1985 the said vehicle was used for the carriage of a thing liable to forfeiture, namely 297.43 kilograms of herbal cannabis, which had been imported contrary to the prohibition on the importation thereof imposed by section 3 (1) of the Misuse of Drugs Act 1971.

(2) Section 88 (c) of the Customs and Excise Management Act 1979:

In that on or about the 11th day of July 1985 the said vehicle was within the limits of a port, namely Harwich, whilst adapted for the purpose of concealing

If you claim that the said vehicle is not liable to for-feiture you must within one month from the date of this notice of seizure give notice of your claim in writing in accordance with paragraphs 3 and 4 of Schedule 3 to the Customs and Excise Management Act 1979.

As you are outside the United Kingdom and the Isle of Man you must also give the name and address of a solicitor in the United Kingdom who is authorised to accept service of process and act on your behalf.

If you do not give notice of claim within the said period of one month or, if any requirement of the above-mentioned paragraph 4 is not complied with, the goods in question will be deemed to have been duly condemned as forfeited.

If you do give notice of claim in proper form, the Commissioners will take legal proceedings for the condem-

nation of the said goods.
