

The effect of the Order, which will come into operation on 23rd December 1985, will be to impose a 40 m.p.h. speed limit on Steeple Road, Mayland, from 60 metres south-west of The Drive to 100 metres north-east of Mill Road, in the District of Maldon.

A copy of the Order and a map showing the lengths of road in question are available at County Hall, Chelmsford where they may be examined during normal office hours from Mondays to Fridays.

Anyone who wishes to question the validity of any of the Order, or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act, or of any Instrument made under it has not been complied with in relation to the Order, may, within 6 weeks from 12th December 1985, apply to the High Court for this purpose.

#### GOSPORT BOROUGH COUNCIL

##### *Gosport Borough Council Traffic Regulation Order*

Notice is hereby given that the Gosport Borough Council (as agents for the Hampshire County Council) on 17th December 1985 made the following Orders under sections 1 (1) and (2), 2 (1) to (3) and 4 (2) of the Road Traffic Regulation Act 1984, the effect of which will be as follows:

##### *Prohibition of waiting at any time*

##### *(a) The Borough of Gosport (Trafalgar Square) (No. 4) Order 1985*

- (i) North side.
- (ii) West end.
- (iii) South side:
  - (a) from its western end in an easterly direction for a distance of 4 metres;
  - (b) from a point 9 metres east of its western end to its eastern end.

##### *(b) The Borough of Gosport (Village Road) (No. 5) Order 1985*

South side, adjacent to the Village Home Public House and Threshers Off Licence.

##### *(c) The Borough of Gosport (Bury Crescent) (No. 7) Order 1985*

The eastern side, from its junction with Bury Road to a point 9 metres north of its junction with Ingledene Close.

##### *(d) The Borough of Gosport (Jamaica Place) (Prohibition of Waiting) (No. 6) Order 1985*

##### *Prohibition of Waiting at any time*

##### *(a) Jamaica Place*

- (i) The north and south sides, for short distances, at its junction with Shaftesbury Road.
- (ii) The north side, at its junction with Willis Road for a short distance.
- (b) Willis Road, west side, for a short distance north of Jamaica Place.

##### *Prohibition of Waiting (Monday to Saturday inclusive)* 8 a.m. to 6 p.m.

##### *(c) Jamaica Place*

- (i) The north side, from existing restriction eastwards to commencement of restriction at junction of Jamaica Place and Willis Road.
- (ii) The south side, from existing restriction eastwards to the rear of Royal Arms Public House (excluding the layby).

The Order will come into operation on 23rd December 1985.

Exemptions to the Orders will permit for certain purposes including picking up and setting down of passengers, loading and unloading of goods, building operations, road and similar works and the disabled.

The Orders together with plans showing the lengths of roads concerned may be examined in my Department at the Town Hall, Gosport during normal office hours (except Saturdays).

If you wish to question the validity of any of the Orders, of any provision contained in them on the grounds that it is not within the powers conferred by the Act, or on the grounds that any requirements of the Act, or of any Instrument made under it have not been complied with in

relation to the Orders, you may, within 6 weeks from the date of making the Order, apply to the High Court for this purpose.

#### HASTINGS BOROUGH COUNCIL

##### *The Hastings Borough Council (Parking Places for Medical Practitioners) (Bexhill Road) Order 1985*

#### HEREFORD AND WORCESTER COUNTY COUNCIL

##### *The County of Hereford and Worcester (B4090 Hanbury Street, Droitwich) (Prohibition of Waiting) Order 1986*

Notice is hereby given that Hereford and Worcester County Council propose to make an Order under section 1 (1) and (2), 2 (1) to (3) and 4 (2) of, and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 and of all other enabling powers the effect of which will be to prohibit waiting at any time on the south side of the B4090 Hanbury Street in the Town of Droitwich, in the District of Wychavon in the County of Hereford and Worcester, which extends from its junction with Queen Street to a point 15 metres (49 feet) west of its junction with The Holloway.

Exemptions in the Order will permit waiting for the purpose of:

- (a) picking up and setting down passengers;
- (b) loading and unloading goods;
- (c) delivering and collecting mail by Post Office vehicles;
- (d) delivering and collecting furniture and effects with police consent;
- (e) any building or demolition operation, the removal of any obstruction to traffic, the maintenance of the roads and the supply of gas, electricity and water and maintenance of any telecommunications apparatus;
- (f) the fire brigade, ambulance or police services.

An exemption in the Order also permits the waiting by disabled persons' vehicles displaying a badge issued under the Local Authority's "orange badge" scheme for a limited period of 2 hours, return prohibited within a further period of 1 hour.

Full details of these proposals are contained in the draft Order which together with a map showing the side of length of road affected and a statement of the Council's reasons for proposing to make the Order, may be examined from Monday to Friday during normal office hours at:

- (1) County Hall, Spetchley Road, Worcester.
- (2) Wychavon District Council Offices, Norbury House, Friar Street, Droitwich.

Objections to the proposal, giving reasons, must be sent in writing to the undersigned by 20th January 1986.
