## **ROAD TRAFFIC REGULATION ACT 1984**

The Liverpool-Leeds-Hull Trunk Road (A63) (South Docks Road, Hull) (24 Hour Main Carriageway Clearway) Order 1985.

  - (iii) the maintenance, improvement or reconstruction of the trunk-road;
  - (iv) the laying, erection, alteration or repair in or near the trunk road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus;
- (b) in respect of a vehicle being used:
  - (i) for police, fire brigade or ambulance purposes;
  - (ii) in the service of a local authority or of a water authority;
- (c) in respect of a vehicle waiting when the person in control of it:
  - (i) is required by law to stop;
  - (ii) is obliged to stop in order to avoid an accident;
  - (iii) is prevented from proceeding by circumstances outside his control.
- (d) to a vehicle waiting upon the direction or with the permission of a police constable in uniform or of a traffic warden.

No person, shall cause or permit any vehicle to wait on any verge or layby immediately adjacent to any of the main carraigeways for the purpose of selling goods from that vehicle unless the goods are immediately delivered at or taken into premises adjacent to the vehicle from which the sale is effected.

Any person who desires to question the validity of, or of any provision contained in, the Order, on the ground that it is not within the powers with respect to the Order conferred by the above Act, or on the ground that any requirement of, or of any instrument made under, any provision of that Act has not been complied with in relation to the Order may, within 6 weeks of 24th December 1985, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein
