Any person who wishes to make representations about the proposals should do so in writing to the Water Re-sources Manager, Yorkshire Water Authority, Rivers Division, 21 Park Square South, Leeds LS1 2QG, before the end of the said period.

After the expiry of the said period the Authority will be entitled to pass a resolution by virtue of which a varia-tion of the licence authorising the proposals shall be deemed to be granted, unless the Secretary of State for the Environment, either in consequence of any representation made with regard to the proposals or otherwise, requires an application for the variation to be made to him. #### LINCOLNSHIRE COUNTY COUNCIL
