

under sections 14 and 125 of the Highways Act 1980 and which, as confirmed, provides for authorising the Council:

- (a) to improve, raise, lower or otherwise alter highways,
- (b) to stop up highways,
- (c) to construct new highways,
- (d) to stop up private means of access to premises, and
- (e) to provide new means of access to premises,

all on or in the vicinity of the route of the classified road which the Council are proposing to construct from a point on the Penzance to Lands End Principal Road (A30) near Trereife Lodge, west of Penzance, approximately 150 metres north-east of its junction with the Trereife to Stone Cross Road (B3317) and the Penzance to Stable Hobba Road (A3077) in a generally north-easterly direction crossing the Penzance to St. Just Road (A3071) at Mount Misery Corner and the Penzance to Madron Road (B3312) at Heamoor, where it forms a roundabout in each case, and then easterly to Treneere, where it forms a third roundabout, then to its termination point where it forms a junction with a roundabout to be constructed by the Secretary of State at Eastern Green as part of the A30 Trunk Road Long Rock Bypass.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Highways Act 1980 or on the ground that any requirement of that Act or of any regulations made thereunder has not been complied with in relation to the

Order, may, within 6 weeks of 30th January 1986 apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
