## TOWN AND COUNTRY PLANNING ACT 1971

*Stopping-Up of Whittaker Street, Chadderton*

## ROAD TRAFFIC ACTS

## BEVERLEY BOROUGH COUNCIL

*The East Yorkshire Borough of Beverley Borough Council (Salisbury Street, The Weir and Tower Hill, Hessle) (Prohibition and Restriction of Waiting) Order 1986.*

Notice is hereby given that on 30th January 1986 the East Yorkshire Borough of Beverley Borough Council made the above-named Order under sections 1 (1) and (2), 2 (1) to (3) and 4 (2) of the Road Traffic Regulation Act 1984.

This Order, which makes it unlawful for any person to cause any vehicle to:

I. (a) *Wait at any time on:*

1. *Salisbury Street*, Hessle, that length which extends from its junction with *The Weir* in a westerly direction for a distance of 15 metres.
2. *The Weir*, Hessle, that length which extends from its junction with *Tower Hill* to a point 52 metres north of the northern kerb-line of *Salisbury Street*.
3. *Tower Hill*, Hessle,  
The north and east sides:

(i) from the western kerb-line of *Northgate* in a westerly direction for a distance of 29 metres;

(ii) from a point 84 metres west of the western kerb-line of *Northgate* in a westerly and northerly direction to a point opposite the northern kerb-line of *Tower Hill Drive*.

The south and west sides from a point 79 metres west of the western kerb-line of *Southgate* in a westerly and northerly direction to the southern kerb-line of *Tower Hill Drive*.

(b) *Wait between 8 a.m. and 6 p.m. on any day other than a Sunday on:*

*The Weir*, Hessle, the east side, from a point 117 metres north of its junction with *Ferriby Road* to a point 52 metres north of the northern kerb-line of *Salisbury Street*.
