#### CERTIFICATES OF TAX DEPOSITS (SERIES 6)

On and after 19th February 1986 the rates of interest applicable to deposits accepted under the Prospectus (Series 6) dated 11th October 1982 will be as follows:

(a) for deposits of £100,000 or over:

in the relevant year of the interest period		

(b) for deposits of less than £100,000: 11½ per cent if the deposit is applied in payment of a scheduled liability and 7½ per cent if the deposit is withdrawn for cash.

For deposits made under the earlier Prospectus (Series 5) which reach the fourth anniversary of the deposits in accordance with the terms and conditions set out therein: 12½ per cent if the deposit is applied in payment of a scheduled liability, and 7½ per cent if the deposit is withdrawn for cash.
