DYFED COUNTY COUNCIL

The County of Dyfed (Various Roads, Milford Haven) (Prohibition and Restriction of Waiting) Order 1986

Notice is hereby given that on 24th February 1986, the Dyfed County Council made an Order under sections 1(1) and (2), 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984 ("the Act").

The effect of this Order is:-

- 1. To prohibit waiting at any time in the lengths of road or on the sides of road specified in Schedule 1 to this Notice.
- To prohibit waiting between the hours of 8 a.m. and 6 p.m. on any day except Sunday on the side of road specified in Schedule 2 to this Notice.

The Order contains the usual exemptions including the right for passengers to board or alight from a vehicle, for the loading or unloading of goods, for the carrying out of building operations and other works, for the performance of statutory powers or duties and to enable a vehicle to take in petrol, oil, water or air from any garage situated adjacent to the lengths of road or sides of road affected by the Order.

In addition, the Order contains the usual parking concessions

for disabled persons in accordance with the Orange Badge Scheme.

The Order will come into operation on 4th March 1986, and a copy of the Order, together with a map indicating the lengths of road and sides of road affected, may be inspected at the offices of the Dyfed County Council at County Hall, Carmarthen, during normal office hours.

Any person who desires to question the validity of this Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Act, or on the grounds that any requirement of the Act or of any instrument made under it has not been complied with in relation to the Order, may, within 6 weeks of the date on which the Order was made, apply to the High Court for this purpose.
