ROYAL WARRANT OF . PRECEDENCE

The QUEEN has been graciously pleased to ordain and declare that Daphne Angela wife of George Edward Brian Brazier-Creagh, Esquire, Lieutenant-Colonel Regular Army Reserve of Officers shall hence forth have, hold and enjoy the same title, rank, place, pre-eminence and precedence as the daughter of a Baron which would have been due to her had her father Francis Cecil Brownlow, Esquire, (commonly called The Honourable Francis Cecil Brownlow) survived his nephew William George Edward Baron Lurgan of Lurgan, Co. Armagh and thereby succeeded to the title and dignity of Baron Lurgan of Lurgan Co. Armagh.

And to command that the said Royal Concession and Declaration be recorded in Her Majesty's College of Arms. (2 SI)

TENDERS FOR TREASURY BILLS

The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Securities Office, Bank of England, Threadneedle Street, on Friday, 7th March 1986 at 1 p.m., for Treasury Bills to be issued under the Treasury Bills Act 1877, and the National Loans Act 1968, to the amount of £100,000,000.

2. The Bills will be in amounts of $\pounds 5,000$, $\pounds 10,000$, $\pounds 25,000$, $\pounds 50,000$, $\pounds 100,000$, $\pounds 250,000$ or $\pounds 1,000,000$. They will be dated at the option of the tenderer on any business day from Monday, 10th March 1986 to Friday, 14th March 1986 inclusive and will be due 91 days after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated and the net amount per cent. (being a multiple of half of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. Notification will be sent on the same day as Tenders are received to the persons whose Tenders are accepted in whole or in part. Payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. on the day on which the relative Bills are to be dated.

7. Tenders must be made on the printed forms which may be obtained from the Bank of England.

8. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders. (16 SI)
