##### DIRECTION UNDER ARTICLE 4(1) OF THE TOWN AND COUNTRY PLANNING GENERAL DEVELOPMENT ORDERS 1977-85

##### *Land and Buildings in and near The Square, Withnell Fold Conservation Area*

Notice is hereby given that the Direction made on 31st January 1986, under Article 4(1) of the Town and Country Planning General Development Orders, 1977-85, by the Chorley Borough Council, being the appropriate Local Planning Authority within the meaning of the said Article, affecting certain land and buildings in and near The Square Withnell Fold Conservation Area, was approved, with modification, by the Secretary of State for the Environment on 10th April 1986. The Direction comes into force on 1st May 1986. Permissions granted by Article 3 of the said Orders shall not apply in respect of development within the curtilage of a dwellinghouse and sundry minor

operations within paragraphs 1, 2 and 4 of Class I and paragraphs 1 and 3 of Class II referred to in Schedule 1 of the Orders. The extent of the area covered by this Direction is more particularly delineated on the plan accompanying the Direction.

The Direction will apply to an area of land within the Withnell Fold Conservation Area comprising the terraced cottages in the vicinity of The Square, two other terraces south of The Square and the former village reading room, and is aimed at bringing certain permitted development rights under the control of the Local Planning Authority. The effect of the Direction will be to prohibit the enlargement, improvement and other alteration of dwelling-houses; insertion of dormers and roof lights and other alterations to roofs; alterations and enlargement of windows; erection of porches; construction of hardstandings; erection or alterations of all means of enclosure; and the painting of exterior buildings or works, unless planning permission is first obtained.
