## TREASURY

#### VALUE ADDED TAX

Treasury directions dated 24th March 1986 under section 27(2) and (3) of the Value Added Tax Act 1983 as to the supply of goods and services by Government departments.

(These directions amend the Treasury directions given under section 27(2) and (3) of the Value Added Tax Act 1983 dated

27th March 1985 and published in the London Gazette of Friday, 17th May 1985.)

The Treasury, in exercise of the powers conferred on them by section 27(2) and (3) of the Value Added Tax Act 1983 (1983) c. 55), hereby direct as follows:

- 1. These directions shall come into operation on 1st April 1986.
- 2. In these directions:
  - "the directions" mean the Treasury directions given under section 27(2) and (3) of the Value Added Tax Act 1983 dated 27th March 1985;
    - "the Schedules" mean the Schedules to the directions; and
    - "column (1)" and "column (2)" respectively mean column (1) and column (2) of the Schedules.
- 3. Column (1) and column (2) of the Schedules specified in the left-hand column of the table to this paragraph shall be amended respectively in accordance with the instructions contained in the middle and right-hand columns of the table.
