HARBOURS ACT 1964

Harwich Dock Company Employment Order

Notice is hereby given that the Harwich Dock Company Limited (hereinafter referred to as "the Company") have applied to the Secretary of State for Transport to make a Harbour Empowerment Order under section 16 of the Harbours Act 1964.

The objects of the proposed Order are:

- (1) To incorporate the provisions of the Harbours Docks and Piers Clauses Act 1847 with exceptions and am-
- (2) To define the area within which the Company shall exercise jurisdiction as a harbour authority and within which the powers of the harbour master shall be exercised.
- (3) To authorise the Company, within the limits of deviation shown on the deposited plan and according to the levels shown on the deposited sections, to con-struct the following works in the parish of Harwich in the district of Tendring in the county of Essex:
 - Work No. 1: A solid faced quay, comprising steel sheet piling, bearing piles, reinforced concrete and infill material commencing at the western extremity of the existing berth number 2/3 and proceeding thence in a northerly direction for a distance of 23 thence in a northerly direction for a distance of 23 metres, thence in an east-north-easterly direction for a distance of 244 metres, thence in a south-south-easterly direction for a distance of 47 metres, thence in an east-north-easterly direction for a distance of 245 metres, thence in an east-north-easterly direction for a distance of 63 metres, thence returning in a west-south-westerly direction to the eastern extremity of existing berth number 5 and thence following the face of that berth and subsequently of existing berths numbers 4 and 2/3 respectively, to the point of commencement and together with all necessary excavation of the bed of the harbour.
 - Work No. 2: A quay of open construction comprising bearing piles and reinforced concrete commencing at the extreme south-east corner of the Navyard and proceeding in an east-north-easterly direction for a distance of 245 metres, thence proceeding in a north-north-westerly direction for a distance of 62 metres to abut and join the extreme south-east corner of Work No. 1, thence in a west-south-westerly direction for a distance of 245 metres and thence in a south-south-easterly direction for a distance of 62 metres to the point of commencement;

and to enclose and reclaim so much of the bed of Harwich harbour and of the foreshore as lies within the limits of deviation shown on the deposited plan;

- (4) To empower the Company to erect, construct and maintain all such subsidiary works and conveniences as may be necessary or expedient for the purposes of or in connection with the construction, maintenance or use of the works:
- (5) To limit the time within which the works are completed to 10 years from the coming into operation of the Order, or such extended time as the Secretary of State may allow;

- (6) To empower the Company, for the purposes of con-structing and maintaining the works or otherwise for the purposes of their undertaking to deepen, dredge, scour, cleanse, alter and improve so much of the harbour and foreshore as lies within the limits of jurisdiction:
- (7) To enable the Company to sell, lease or otherwise dispose of their undertaking or to transfer any pro-perty, rights, liabilities or obligations of the Company to any of their subsidiaries;
- (8) To empower the Company to make charges for services and facilities provided by them; to appropriate and set apart any part of their undertaking for the exclusive use of any particular vessel or class of vessel; to require the removal of goods left on or in any part of their undertaking;
- (9) To enact provisions incidental to, or consequential upon, the above-mentioned purposes.
