The Order shall come into operation on 13th May 1986.

A copy of the Order, together with the principal Order which it varies, and which contains provisions relating to charges and use of car parks, and a map showing the extent of the Order, may be inspected at my offices during normal office hours.

Any person who wishes to question the validity of the Order, or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or any Instrument made under it has not been complied with in relation to the Order, may, within 6 weeks from 12th May 1986, make application to the High Court for this purpose.
