HIGHWAYS ACT 1980

The North of Newcastle-Under-Lyme to Tarvin Trunk Road (A51 Barbridge By-Pass) Order 1986 and

The North of Newcastle-Under-Lyme to Tarvin Trunk Road (A51 Barbridge By-Pass) (Side Roads) Order 1986

The Secretary of State for Transport hereby gives notice that he has made the following Orders:

1. An order under section 10 of the Highways Act 1980, the effect of which is to provide that a road about 0.88 Kilometres in length which he proposes to construct at Barbridge (from a point approximately 85 metres south of the northern boundary of the Jolly Tar Public House on the trunk road to a point approximately 70 metres north of the southern boundary of the boundary known as Hillcrest on the trunk road) in the County of Cheshire shall become a trunk road as from the date when the Order comes into operation and that the length of the North of Newcastle-Under-Lyme to Tarvin Trunk Road to be superseded shall cease to be a trunk road as from the date on which notice is given by him to the County Council of Cheshire that the new trunk road is open for through Traffic.

2. An Order under sections 14 and 125 of the Highways Act 1980, the effect of which is to:

(a) authorise him-

(i) to improve, raise, lower or otherwise alter highways;(ii) to stop up highways;

(iii) to construct new highways; (iv) to stop up private means of access to premises; (v) to provide new means of access to premises.

(b) to provide for the transfer of the said new highways to the County Council of Cheshire as from the date on which he notifies the Council that the new highways have been completed and are open.

Copies of the two Orders and the relevant plans have been deposited at the Department of Transport, Marsham Street, London S.W.1; at the offices of the Director (Transport), Departments of the Environment and Transport, North West Region, Sunley Tower, Piccadilly Plaza, Manchester M1 4BE; Cheshire County Council, County Hall, Chester and Backford Hall, Chester; Crewe & Nantwich Borough Council, Delamere Street Crewe where they are open to inspection free of charge of Street, Crewe; where they are open to inspection free of charge at all reasonable hours.

Any person aggrieved by the Order and desiring to question the validity thereof or of any provision contained therein, on the ground that any requirement of that Act or of any regulations made thereunder, has not been complied with in relation to the Order may within 6 weeks from 14th May 1986 or within 6 weeks from the date of publication of this notice if such period shall expire later, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
