*The Epsom (Ashley Centre) Parking Order 1986
Notice of Proposals*

Notice is hereby given that the Council of the Borough of Epsom and Ewell proposes to make the Epsom (Ashley Centre) Parking Order 1985 under section 35 of the Road Traffic Regulation Act 1984 and all other powers them enabling in that behalf.

The proposed Order would regulate the use of the Ashley Centre Multi-Storey Car Park at the Ashley Centre, Epsom.

The car park will be available for use at all times by motor cars (including commercial vehicles) not exceeding 30 cwt. and 6 feet 3 inches overall height, invalid carriages, motor cycles and pedal cycles.

The charges for the use of the car park during Mondays to Fridays excluding bank holidays are to be as follows:

Motor Cars (including disabled persons' vehicles):

- up to half hour, 10p.
- up to 1 hour, 20p.
- up to 2 hours, 30p.
- up to 3 hours, 50p.
- up to 4 hours, 70p.
- up to 5 hours, £2.
- up to 24 hours, £5.

Between 6.30 p.m. and 8 p.m. Nil.
Lost or damaged ticket, £5.

Motor Cycles and Pedal Cycles, Nil.

The charges for the use of the car park on Saturdays are to be increased to the following levels:

Motor Cars (including disabled persons' vehicles):

- up to half hour, 20p.
- up to 1 hour, 30p.
- up to 2 hours, 40p.
- up to 3 hours, 60p.
- up to 4 hours, 80p.
- up to 5 hours, £2.
- up to 24 hours, £5.

Between 6.30 p.m. and 8 p.m. Nil.
Lost or damaged ticket, £5.

Motor Cycles and Pedal Cycles, Nil.

On Sundays and Bank Holidays when the Ashley Centre is not open for trading there will be no charge for parking.

The Order will also empower the Council to issue pass cards enabling entry to the car park on terms agreed between the Council and the pass card holder.

The Council will be enabled to charge a lesser charge on any day or days specified by notice displayed in the car park.

An excess charge shall be payable in the following circumstances:

- (i) Where a vehicle other than those vehicles authorised to use the parking place is left in the parking place.
- (ii) Where a vehicle is parked otherwise than wholly within a marked bay or a vehicle other than a disabled person's vehicle or motor cycle or pedal cycle is parked in bays or areas reserved for those vehicles.

The amount of the excess charge will be the sum of £5 if paid within 14 days of the contravention concerned or £20 if paid thereafter.

The Order will provide for a "pay on foot" system of payment of car parking charges.

The Order will contain further provisions as to the use of the parking place, and enabling if necessary its temporary closure.

A copy of the proposed Order, and a statement of the Council's reasons for proposing to make it may be inspected at the Town Hall, The Parade, Epsom, at any time between 8.50 a.m. and 5 p.m. Mondays to Fridays inclusive until 12th June 1986.

Any objection to the proposed Order should be made in writing not later than the date specified in paragraph 9 of this notice and addressed to the Town Clerk and Chief Executive, Town Hall, The Parade, Epsom, quoting ref. SM/C/1/18. The grounds for making the objection should be stated.

The Epsom (Off-street Parking Places) (Ninth Amendment) Order 1986

The Epsom (Market Place Parking) (Eighth Amendment) Order 1986

Notice is hereby given that the Council of the Borough of Epsom and Ewell propose to make the Epsom (Off-street Parking Places) (Ninth Amendment) Order 1986 in exercise of their powers under section 35 (1) of and Paragraph 27 (1) of Schedule 9 to the Road Traffic Regulation Act 1984 and propose to make to Epsom (Market Place Parking) (Eighth Amendment) Order 1986 under section 45 (1) of and paragraphs 27 (1) of Schedule 9 to the Road Traffic Regulations Act 1984 pursuant to arrangements made with Surrey County Council under section 101 of the Local Government Act 1972.

The effect of these Orders is to amend the Epsom (Off-street Parking Places) Order 1976 and the Epsom (Market Place) Parking Order 1978 as follows:

- (i) The excess charges will be increased to £5 if paid within 14 days or £20 if paid thereafter:

This applies to all the Council's pay and displays car parks, namely:

- The Market Place (No. 9)
- High Street (No. 1)
- Upper High Street Car Park (No. 3)
- Hook Road Car Park (No. 4)
- Depot Road Car Park (No. 5)
- The Swimming Centre Car Park (No. 10)
- The Grove Cottage Car Park Ewell (No. 6)
- The Dorset House Car Park Ewell (No. 7)

An excess charge is payable if a vehicle is left in any car park during the charging hours longer than the initial period for which payment was made, or without a ticket being exhibited on the vehicle or otherwise than in a position in which vehicles of that class may wait:

- (ii) The minimum charge for the High Street Car Park Epsom (Car Park No. 1) on a Saturday will become 30 pence. The charges for cars and other than disabled persons' vehicles will then be:

Monday to Friday, up to ½ hour 10p, up to 2 hours 30p.

Saturday, up to 2 hours 30p.

The maximum parking period allowed at this car park will still be 2 hours.

- (iii) The charges for the Hook Road Car Park will be set out in more detail in preparation for its re-opening when construction of the Multi-Storey car park is complete. The charges will remain the same as those for the Council's other long term car parks, but drivers wishing to park for more than 5 hours will be required to use levels 3A, 3B, 4A, 4B, 5A and 5B of the car park. This is to prevent lower levels becoming congested by long-term parkers to the detriment of the larger number of shoppers. The Multi-Storey car park will only be open to vehicles not exceeding 6 feet 3 inches maximum height. Alternative long stay car parks are available for high sided vehicles at Depot Road, Upper High Street and the Swimming Centre car parks.

Other charges at the Council's pay and display car parks will not be changed by the Orders.

Copies of the proposed Orders and a statement of the Council's reasons for proposing to make them may be inspected at the Town Hall, The Parade, Epsom, at any time between 8.50 a.m. and 5 p.m. Mondays to Fridays inclusive until 12th June 1986.

Any objection to the proposed Orders should be made in writing not later than the date specified in paragraph 3 of this notice and addressed to the Borough Secretary and Solicitor, The Town Hall, The Parade, quoting ref. SM/C/1/5. The grounds for making the objection should be stated.
