The Borough of Eastbourne (Outer Central Area) (Waiting Restriction Modification No. 1) Order 1986

Notice is hereby given that the Eastbourne Borough Council acting as agents for the East Sussex County Council propose to make an Order under sections 1 (1), (2), (3), Schedule 9, paragraphs 20 and 27 of the Road Traffic Regulation Act 1984.

The effect of the Order will be:

WEST GLAMORGAN COUNTY COUNCIL

West Glamorgan County Council (Dunvant Road, Dunvant) (Gwydr Square, Uplands, Swansea) and (Pen Y Cae Road, Port Talbot) (Prohibition of Waiting) Orders 1986

Notice is hereby given that the West Glamorgan County Council in pursuance of its powers under the Road Traffic Regulation Act 1984 on 5th May 1986 made traffic orders to prohibit waiting at any time on the following lengths of road:

(i) *Dunvant Road*, north side, Dunvant, from a point in line with the western kerb-line of Llanerch Road for a distance of 60 metres in a westerly direction. This Order will come into operation on 2nd June 1986.

West side, between points 38 metres south-east of the southern kerb-line of Gwar y Caeau and 62 metres north of the northern kerb-line of Gwar y Caeau a distance of approximately 105 metres.

This Order will come into operation on 26th May 1986.

A copy of the several Orders and appropriate plan may be inspected in the County Clerk's Department, County Hall, Swansea, during normal office hours.

Any person wishing to object to the Order on the grounds that it is not within the powers of the Act of 1984, or any Instrument made thereunder, or that any requirement thereof has not been complied with, may, within 6 weeks of the date of this notice, apply to the High Court for that purpose.
