No waiting at any time

(i) *Heathfield Avenue*, east side, between its junction with High Street and a point 15 metres north of that junction.

(ii) *High Street*, north side, between its junction with Heathfield Avenue and a point 15 metres east of that junction.

SCHEDULE 2

No waiting 8 a.m. to 6 p.m. Monday to Saturday

High Street, north side, between points 55 and 105 metres east of the eastern kerb-line of Heathfield Avenue.

SCHEDULE 3

1 hour limited waiting return prohibited within 1 hour

Between points 15 metres and 55 metres east of the eastern kerb-line of Heathfield Avenue.

HAMPSHIRE COUNTY COUNCIL

Traffic Restrictions in and adjacent to the A30 at Blackwater

Notice is hereby given that Hampshire County Council proposes making a Road Traffic Regulation Order as follows:

Effect of Order: To implement the traffic restrictions described below in the following roads at Blackwater:

(i) *A30 London Road*, box junctions on:

(a) the north side of its junction with Rosemary Lane; and

(b) the south side at its junction with Vicarage Road.

NOTE: A box junction comprises yellow road markings which denote an area where no vehicle is permitted to stop unless required to do so prior to making a right-hand turn by the presence of stationary vehicles waiting to complete a right-hand turn.

(ii) *The service road situated east of Rosemary Lane and adjacent to the north side of the A30 London Road:*

"no waiting at any time (with exemptions for loading/unloading and disabled drivers) on:

(a) its north side for a distance of 27 metres along the entire frontage of the Royal Swan public house (including the vehicular access thereto); and

(b) on its west/south side for a distance of 25 metres between its easternmost junction with the A30 London Road and a point opposite the west side of C. and H. Smith Newsagents.

One way traffic in an eastbound direction only in that length situated west of its easternmost junction with the A30 London Road;

No entry into the A30 London Road at its westernmost junction therewith.

NOTE: The above measures are proposed in conjunction with the installation of traffic signals.

HEREFORD AND WORCESTER COUNTY COUNCIL

ROAD TRAFFIC REGULATION ACT 1984

The County of Hereford and Worcester (A451 Vale Road, Stourport-on-Severn) (Prohibition of Waiting) Order 1986.

Notice is hereby given that Hereford and Worcester County Council propose to make an Order under sections 1 (1) and (2), 2 (1) to (3) and 4 (2) of, and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, and of all other enabling powers, the effect of which will be to prohibit waiting at any time on the following sides of lengths of A451 Vale Road in the town of Stourport-on-Severn, in the District of Wyre Forest in the County of Hereford and Worcester:

(a) west side, from a point 55 metres (180 feet) north of its junction with the A4025 Mitton Street in a northerly direction to its junction with B4195 Foundry Street;

(b) east side, from its junction with A4025 Gilgal to its junction with B4195 Foundry Street.

Exemptions in the Order will permit waiting for the purpose of:

(a) picking up and setting down passengers;

(b) loading and/or unloading goods;

(c) delivering and collecting mail by Post Office vehicles;

(d) delivering and collecting furniture and effects with police consent;

(e) any building or demolition operation, the removal of any obstruction to traffic, the maintenance of the roads and the supply of gas, electricity and water and maintenance of any telecommunications apparatus;

(f) the fire brigade, ambulance or police services.

An exemption in the Order also permits the waiting by disabled persons' vehicles displaying a badge issued under the local authority's "orange badge" scheme for a limited period of 2 hours, return prohibited within a further period of 1 hour.

Full details of these proposals are contained in the draft Order which, together with a map showing the sides of lengths of road affected and a statement of the Council's reasons for proposing to make the Order, may be examined from Monday to Friday during normal office hours at:

(2) Wyre Forest District Council Offices, Civic Centre, Stourport-on-Severn.
