In accordance therewith the Chancellor of the Exchequer now recommends that with effect from 21st May 1986 and until the coming into operation of a further determination:

- I. The rate of interest applicable to any such fixed rate loan will be that in force on the day the authority applies to borrow or, if the application is before noon three working days before the loan is credited to the account of the authority's banker, the rate in force at 11 a.m. two banking days before credit day;
- II. Different rates of interest shall be charged on such fixed rate loans according to whether the principal of a loan is repaid by instalments or at maturity and, if repaid by instalments, whether by equal instalments of the principal with interest paid on the decreasing balance of the principal (E.I.P.), or by instalments of equal repayments of the principal and interest paid thereon (E.R.);
- III. The rates of such interest shall be:

The Trunk Road (A483) (Penllergaer, West Glamorgan) (Prohibition of Traffic) Order 1986

Notice is hereby given that the Secretary of State for Wales proposes to make an Order under section 1 and 2 of the Road Traffic Regulation Act 1984.
