# **GWENT COUNTY COUNCIL**

Gwent County Council, Kingsway Service Road Area, Newport, Proposed Traffic Management Measures

Notice is hereby given that Gwent County Council, in exercise of their powers under the Road Traffic Regulation Act 1984, have on 23rd May 1986 made Orders the effect of which will be:

If you wish to question the validity of the Orders, or of any provision contained in them, on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of the Act or of any Instrument made under it has not been complied with in relation to the Orders, you may, within 6 weeks from 23rd May 1986, apply to the High Court for this purpose.
