The Council of the County of North Yorkshire (Prohibition of Driving) (Park Road, Glusburn) Order 1986

Notice is hereby given that the Council of the county of North Yorkshire propose to make an Order under sections 1 (1) and (2), 2 (1) to (3), 3 (2) and 4 (1) of the Road Traffic Regulation Act 1984 the effect of which will be to prohibit any motor vehicle from proceeding along Park Road, Glusburn, from a point 30 metres west of its junction with the western kerb-line of Station Road to a point 5 metres west of that same junction.

A copy of the draft Order, together with a map showing the road affected and a statement of the Council's reasons for proposing to make the Order may be inspected at County Hall, Northallerton, and at the Glusburn and Crosshills Library, Main Street, Crosshills, during normal office hours.
