bounded on the south by the M61 Motorway, on the east by St. Helens Road (A579) and lies east of Hunger Hill

## Description of Public Rights of Way

## The Metropolitan Borough of Bolton

- 1. Footpath No. 115 which runs from the junction of footpath No. 116 and footpath No. 120, 230 metres due south of Hermon Bank Farmhouse, and runs in a generally north-north-easterly direction for a distance of about 195 metres to its junction with footpath No. 114 and footpath No. 119, adjacent to the railway bridge east of Hermon Bank Farm.
- 2. Footpath No. 116 which runs from the junction of footpath No. 115 and footpath No. 120, 230 metres due south of Hermon Bank Farmhouse and runs in a generally southerly direction for a distance of about 250 metres to its junction with footpath No. 118 and footpath No. 122, directly adjacent to the Amenity Refuse Point.
- 3. Part of footpath No. 118 which runs from a point south-west of Garnet Fold Farm, on an unnamed track 100 metres west of its junction with St. Helens Road, for a distance of about 240 metres, in a generally west-south-westerly direction to the junction of footpath No. 116 and footpath No. 122 directly adjacent to the Amenity Refuse Point.
- 4. Footpath No. 120, which runs from a point about 490 metres, south-west of Hermon Bank Farmhouse, on the northern side of the dismantled railway line, for a distance of about 425 metres in a generally easterly direction to its junction with footpath No. 115 and footpath No. 116, 230 metres due south of Hermon Bank Farmhouse.
- 5. Part of footpath No. 121 which runs, from a point about 500 metres south-west of Hermon Bank Farmhouse, in a generally north-easterly direction, along the foot of

- the dismantled railway line for a distance of about 350 metres to a point 170 metres south-west of Hermon Bank Farmhouse.
- 6. Footpath No. 122, which runs from its junction with footpath No. 116 and footpath No. 118, about 310 metres west-south-west of Garnet Fold Farm, in a generally west, south-westerly direction for a distance of about 300 metres to its junction with footpath No. 123, about 110 metres north-west of Gorse Wood.
- 7. Footpath No. 123 which runs from its junction with footpath No. 211, on Punch Lane about 145 metres south of Pendlebury Fold in a generally south-easterly direction for a distance of about 520 metres to its junction with footpath No. 122 about 100 metres north-west of Gorse Wood.
- 8. Part of footpath No. 211 which runs in a generally southerly direction along the line of Punch Lane, from a point about 13 metres due south of Pendlebury Fold for a distance of about 132 metres, to its junction with footpath No. 123.

## Description of Alternative Ways proposed to be made available

From a point about 500 metres south-west of Hermon Bank Farmhouse, on the footpath No. 121 in a generally north-easterly direction for a distance of about 550 metres, to the junction of footpath No. 115 and footpath No. 114 and footpath No. 119, at a point about 8 metres south-east of the railway bridge adjacent to Hermon Bank Farmhouse, on an unnamed track which leads from Hermon Bank Farm to Hulton Lane.
