

SOUTHEND-ON-SEA BOROUGH COUNCIL

*Southend-on-Sea Borough Council (Brendon Way Area)
Prohibition of Waiting Order 1986*

Notice is hereby given that the Council of the Borough of Southend-on-Sea made an Order on 23rd May 1986 pursuant to arrangements under section 101 of the Local Government Act 1972 with the County Council of Essex in exercise of the powers of the said County Council under sections 1(1) and (2), 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act the effect of which will be to prohibit waiting in parts of Bideford Close, Brendon Way and Lymptstone Close as follows:

<i>Length of Road</i>	<i>Side of Road</i>	<i>Waiting Limited</i>
Brendon Way from the north kerbline of the north carriage-way of Prince Avenue northwards for a distance of 20 metres.	West	24 Hours Daily
Brendon Way from the north kerbline of the north carriage-way of Prince Avenue northwards for a distance of 55 metres.	East	24 Hours Daily
Brendon Way from a point 15 metres south of the south kerbline of Lymptstone Close to a point 15 metres north of the north kerbline of Lymptstone Close.	Both	24 Hours Daily
Brendon Way from a point 15 metres southwest of the southwest kerbline of Bideford Close to a point 15 metres northeast of the northeast kerbline of Bideford Close.	Both	24 Hours Daily
Bideford Close from the southeast kerbline of Brendon Way southeastwards for a distance of 15 metres.	Both	24 Hours Daily
Lymptstone Close from the west kerbline of Brendon Way westwards for a distance of 15 metres.	Both	24 Hours Daily

Exceptions in the Order permit waiting for the following purposes:

- (a) Picking up or setting down passengers.
- (b) Loading or unloading goods.
- (c) Carrying out essential services connected with the maintenance of the road and the supply of gas, water and electricity.
- (d) By disabled persons vehicles complying with the conditions set out in the order.

The Order will come into effect on 2nd June 1986.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984 or on the grounds that any requirement of the Act or of any instrument made under it has not been complied with in relation to the Order you may within 6 weeks from 23rd May 1986 apply to the High Court for this purpose.

Southend-on-Sea Borough Council (Station Road Area, Thorpe Bay) Prohibition of Waiting Order 1986

Notice is hereby given that the Council of the Borough of Southend-on-Sea made an Order on 23rd May 1986 pursuant to arrangements under section 101 of the Local Government Act 1972 with the County Council of Essex in exercise of the powers of the said County Council under sections 1(1) and (2), 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act the effect of which will be as follows:

to prohibit waiting in lengths of the following roads in the Station Road Area, Thorpe Bay as set out in the Order:

Marcus Avenue, St. James Avenue, St. Augustines Avenue, Parkanaur Avenue, Station Road and Acacia Drive.

Exceptions in the Order permit waiting for the following purposes:

- (a) Picking up or setting down passengers.
- (b) Loading or unloading goods.
- (c) Carrying out essential services connected with the maintenance of the road and the supply of gas, water and electricity.
- (d) By disabled persons vehicles complying with the conditions set out in the Order.

The Order will come into effect on 2nd June 1986.

Notice is hereby given that the Council of the Borough of Southend-on-Sea made an Order on 23rd May 1986 pursuant to arrangements under section 101 of the Local Government Act 1972 with the County Council of Essex in exercise of the powers of the said County Council under sections 1(1) and (2), 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act the effect of which will be as follows:

To prohibit waiting in Nelson Mews as follows:

<i>Length of Road</i>	<i>Side of Road</i>	<i>Waiting Limited</i>
Nelson Mews from a point 28 metres south of the south kerbline of Cliff Town Road southwards and westwards to a point 3 metres west of the north-south section.	West	24 Hours Daily
Nelson Mews from its junction with Nelson Street eastwards and northwards to a point 25 metres north of the east-west section.	South and East	24 Hours Daily

Exceptions in the Order permit waiting for the following purposes:

- (a) Picking up or setting down passengers.
- (b) Loading or unloading goods.
- (c) Carrying out essential services connected with the maintenance of the road and the supply of gas, water and electricity.
- (d) By disabled persons vehicles complying with the conditions set out in the Order.

The Order will come into effect on 2nd June 1986.
