Notice is hereby given that Cambridgeshire County Council have made Orders under the Road Traffic Regulation Act 1984 the effects of which will be:

- (a) An experimental one-way traffic system in Cromwell Place, Oliver Road and The Quadrant with associated prohibition and restriction of waiting to 30 minutes in any hour between 8 a.m. and 6 p.m. Monday to Saturday.
- (b) Experimental one-way traffic in Bridge Street, Merry-land and St. Ives Town Bridge with associated contra-flow cycle lanes in Bridge Street and Crown Street. Only pedal cycles and emergency service vehicles will be allowed to enter Bridge Street over St. Ives Town
- (c) Experimental limited waiting on a length of the southeast side of Bridge Street for 30 minutes in any hour between 8 a.m. and 6 p.m.
- (d) The existing 1 hour limited waiting in East Street, Station Road (south side) and The Broadway will be varied to 30 minutes in any hour between 8 a.m. and 6 p.m. Monday to Saturday with extensions on both sides of The Broadway.
- (e) Lengths of 8 a.m. to 6 p.m. prohibition of waiting in East Street and the south side of Market Hill will be varied to a prohibition at any time.
- (f) A length of the 8 a.m. to 6 p.m. prohibition of waiting on the south side of Market Hill will be varied to allow 30 minutes waiting in any hour between 8 a.m. and 6 p.m. Monday to Saturday.
- (g) The existing prohibition of waiting at any time in Needingworth Road will be extended to cover the junctions with, and short lengths of, Meadow Close and Tenterleas.
- (h) One-way traffic in St. Georges Road from West Street to The Waits.
- (i) A 7.5 tonne maximum gross vehicles weight limit in West Street and St. Georges Road except for loading operations or garaging/servicing operations at pre-mises situated on or adjacent to those roads. Statu-tory undertakers, local authority and other vehicles necessary for building operations will be exempt.

Exemptions for boarding and alighting, disabled drivers, loading (except on the cycle lanes) and vehicles necessary for service operations are incorporated into the orders.

Copies of the Orders, which come into operation on 15th May 1986, and a map showing the effects of the Orders may be inspected at the office of the undersigned and The Chief Executive, Huntingdonshire District Council, Pathfinder House, St. Mary's Street, Huntingdon, during normal office hours office hours.

Any person wishing to question the validity of the Orders or of any provision contained in them on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984 or on the grounds that any requirement of that Act or of any Instrument made under it, has not been complied with in relation to the Orders, may, within 6 weeks from 15th May 1986 apply to the High Court for this purpose.
