European Pharmacopoeia

The Ministers, that is to say the Secretary of State concerned with health in England, the Secretaries of State respectively concerned with health and with agriculture in Wales and in Scotland, the Minister of Agriculture, Fisheries and Food, the Department of Health and Social Services for Northern Ireland and the Department of Agriculture for Northern Ireland, acting jointly, hereby declare under section 65 (7) and (8) of the Medicines Act 1968 that on and after 1st July 1986 that the Monographs contained in the Seventh and Eighth Fascicules of the 2nd Edition of the European Pharmacopoeia, published under the direction of the Council of Europe (Partial Agreement) in accordance with the Convention on the Elaboration of a European Pharmacopoeia are to have effect for the purposes of section 65 of the said Act.

NEW TOWNS ACT 1981

Telford Development Corporation: Extinguishment of Public Rights of Way over Footpath 104 at Priorslee

Notice is hereby given that the Secretary of State for the Environment, in exercise of his powers under section 23 of the New Towns Act 1981 has made an Order extinguishing as from the date of the Order public rights of way over the following route shown by a broken thick black line coloured red on the map referred to therein:

That part of footpath No. 104 from its junction with Lodge Row, Priorslee Village at a point marked A on the map and running in a generally north-easterly direction for a distance of approximately 70 metres to the point marked B on the map adjoining the south-westerly end of the hammerhead of the access road to the Priorslee Village housing plots.

That part of footpath No. 104 from a point marked C on the map approximately 160 metres north-west of its junction with Lodge Row and running in a generally north-easterly direction for a distance of approximately 150 metres to a point marked D on the map, at its junction with the rear access road to Priorslee Hall.

That part of Footpath No. 14 from a point marked A on the map, being its junction with the proposed Eastern District Road (South) and situated approximately 200 metres south of The Woodhouse, and running for a distance of approximately 225 metres in a generally southerly direction to a point marked B on the map being approximately 150 metres north of the northern shore of the Priorslee Balancing Lake.
