*The Spelthorne Borough Council (Various Roads, Sunbury-on-Thames) (Prohibition and Restriction of Waiting) (Amendment No. 8) Order 1986.*

Notice is hereby given that the Council propose to make the above Order under section 1 of the Road Traffic Regulation Act 1984. The Order will further amend the Spelthorne Borough Council (Various Roads, Sunbury-on-Thames) (Prohibition and Restriction of Waiting) Order 1976, prohibiting waiting as follows:

*Extended Service Road west of The Parade, Staines Road West*

- (1) Monday to Saturday 8 a.m. to 6 p.m. waiting limited to 2 hours with return prohibited within 1 hour

(a) on the north side, from the western end of The Parade, Sunbury-on-Thames, westwards for a distance of 26.5 metres approximately to a point 24.5 metres approximately west of the boundary between Nos. 59 and 61, Staines Road West, Sunbury-on-Thames.

(b) On the south side, from the western end of The Parade, Sunbury-on-Thames, westwards for a distance of 12.5 metres approximately to a point 10.5 metres approximately west of the boundary between Nos. 59 and 61 Staines Road West, Sunbury-on-Thames.

*The Spelthorne Borough Council (Upper Halliford By-Pass and Gaston Bridge Road, Shepperton) (Prohibition of Entry to Northbound Carriageway) Order 1986.*

Notice is hereby given that Spelthorne Borough Council on 23rd May 1986 made the above Order pursuant to section 1 of the Road Traffic Regulation Act 1984. The operative date of the Order is 27th May 1986.

#### SPELTHORNE BOROUGH COUNCIL

*The Spelthorne Borough Council (Park Road, Sunbury) (Experimental Prohibition of Heavy Commercial Vehicles) (Extension No. 1) Order 1986.*

Notice is hereby given that the Council on 16th May 1986 made the above Order under section 9 (4) of the Road Traffic Regulation Act 1984. The effect of the Order is to extend for 6 months the provisions of the Spelthorne Borough Council (Park Road, Sunbury) (Experimental Prohibition of Heavy Commercial Vehicles) Order 1985, which prohibits all heavy commercial vehicles the maximum gross weight of which exceeds 7.5 tonnes from entering or proceeding in Park Road, Sunbury, from its junction with Orchard Road to a point 18 metres north of its junction with Oak Grove.

The alternative route for vehicles affected by the Order is the A316, Country Way and A308 Staines Road East.

The purpose of the Order is to prevent heavy commercial vehicles from using Park Road as a through route, to preserve and improve the amenities of the area through which the road runs.

If anyone wishes to question the validity of the Order, or of any provision contained in it on the grounds that either are not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of the Act or of any Instrument made under it has not been complied with in relation to the Order, they may within 6 weeks from the date of this notice, apply to the High Court for this purpose.
