

II. Different rates of interest shall be charged on such fixed rate loans according to whether the principal of a loan is repaid by instalments or at maturity and, if repaid by instalments, whether by equal instalments of the principal with interest paid on the decreasing balance of the principal (E.I.P.), or by instalments of equal repayments of the principal and interest paid thereon (E.R.);

HIGHWAYS ACT 1980

The Fishguard-Bangor Trunk Road (Improvement between The Bakery and London House, Llanon, Side Roads) Order 1986.

The Trunk Road (A477) (Llanddowror, Dyed) (40 m.p.h. Speed Limit) Order 1986

Notice is hereby given that the Secretary of State for Wales proposes to make an Order under section 84 (1) and (2) of the Road Traffic Regulation Act 1984.

The effect of the proposed Order will be to impose a 40 m.p.h. speed limit on that length of the A477 Trunk Road at Llanddowror which extends from a point 58 metres north of the centre line of Picton House Bridge, Llanddowror, in a general northerly and then north-easterly direction to a point 282 metres north of its junction with the access road along the north side of St. Teilo's Church. This includes the length of road currently subject to a 40 m.p.h. speed limit by virtue of the Trunk Road (Llanddowror, Dyfed) (40 m.p.h. Speed Limit) Order 1978 which will be revoked by the proposed Order.
