#### THE WELSH OFFICE

The Trunk Road (A5/A55) (Various Lay-Bys, Clwyd) (Restriction of Waiting) Order 1986

Notice is hereby given that on 22nd September 1986, the Secretary of State for Wales made the above Order which will come into

operation on 27th October 1986.

The effect is as stated in Notice 2 SI in the London Gazette No. 50022 dated 30th January 1985 and Notice 1 SI in the London Gazette No. 50337 dated 4th December 1985.

Anyone wishing to question the validity of the Order or of any of its provisions on the grounds that it is not within the powers of the relevant section of the Act or that any requirement of that Act or any Instrument made under it has not been complied with, may, within 6 weeks of 22nd September 1986, apply to the High Court for this purpose.

A copy of the Order and map may be inspected during the normal office hours at the Offices of Colwyn Borough Council, Civic Centre, Colwyn Bay and at the Area Offices of Glyndwr District Council, Town Hall, Llangollen.

The Trunk Road (A4076) (Johnston, Dyfed) (Prohibition of Waiting) Order 1986

Notice is hereby given that the Secretary of State for Wales proposes to make an Order under sections 1, 2 and 4 of the Road Traffic Regulation Act 1984.

The effect of the proposed Order will be to prohibit (with certain exceptions) the waiting of any vehicle at any time in the length of road specified in the Schedule to this Notice.

A draft Order, together with a plan and statement of reasons for making the Order, may be inspected during normal office hours at the offices of Preseli District Council, Cambria House, Haverford-

west, Pembrokeshire, Dyfed.

Objections, specifying the grounds on which they are made, and quoting reference WR 15/2/243, must be sent in writing to the Welsh Office, Highways Directorate, Roads Administration Division, Government Buildings, Ty Glas Road, Llanishen, Cardiff CF4 5PL by 31st October 1986. In the preparation of an objection and the statement of grounds of objection, it should be borne in mind that the substance of any objection or representation may be communicated to other people who may be affected by it.

#### SCHEDULE

1. That length of the Haverfordwest-Milford Haven Trunk Road (A4076) known as Vine Road at Johnston in the County of Dyfed which extends from a point 155 metres south of its junction with Brickhurst Park in a general notherly direction to a point 55

metres north of the said junction.

2. That length of the Haverfordwest-Milford Haven Trunk Road (A4076) known as St. Peters Road at Johnston in the county of Dyfed which extends from a point 50 metres north-east of its junction with Langford Road in a general south westerly direction to a point 20 metres south west of its junction with Church Road.
