#### **ROAD TRAFFIC REGULATION ACT 1984**

The Trunk Road (A36) (Landford, Wiltshire) (50 m.p.h. speed limit) Order 1986

The Secretary of State for Transport hereby gives notice that he proposes to make an Order under section 84(1) of the Road Traffic Regulation Act 1984, the effect of which will be that no person shall drive any motor vehicle at a speed exceeding 50 miles per hour on that length of the Trunk Road (A36) known as Salisbury Road at Landford in the District of Salisbury in the county of Wiltshire which extends from a point 25 metres west of the centreline of its junction with the western arm of New Road eastwards to the Wiltshire/Hampshire county boundary, a distance of anorxyimately 410 metres
