BADGERS (CONTROL AREAS) (REVOCATION) ORDER 1986

This Order which came into operation on 29th December 1986 revokes the Badgers (Control Areas) Order 1977. That order enabled the Minister of Agriculture, Fisheries and Food to take steps to secure the destruction of badgers in certain areas in the south-west of England in respect of which he was satisfied that destruction of badgers was necessary in order to eliminate, or substantially reduce the incidence of, tuberculosis in cattle.
