*The County Council of Dorset (Ringwood Road (North) and Ferndown Relief Road) (Side Roads) Order 1987*

Notice is hereby given that, The County Council of Dorset have made, and submitted to the Secretary of State for Transport for confirmation, an Order under sections 14 and 125 of the Highways Act 1980 for authorising the Council:

- (a) to improve, raise, lower or otherwise alter highways
- (b) to stop highways
- (c) to construct new highways
- (d) to stop up private means of access to premises and
- (e) to provide new means of access to premises

all on or in the vicinity of the route of the classified road which the Council are proposing to construct between the junction of Dorset Way, Canford Way, and Canford Heath Road, Alderney, Poole and the junction of Cobham Road and Cobham Road to A31 Link Road, Ferndown, Dorset.
