The Stopping-up of Highways (Part of Llanmaes Street, Cardiff) Order 1987

The Secretary of State for Wales hereby gives notice that he has made an Order under section 209 of the Town and Country Planning Act 1971 to authorise the stopping-up of the highway described in the Schedule to this notice to enable development, for which planning permission has been granted, to be carried out.

Copies of the Order and the relevant plan may be inspected free of charge at all reasonable hours at the offices of Cardiff City Council, City Hall, Cardiff.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the above Act or that any requirement of that Act or of any regulation made thereunder has not been complied with in relation to the Order, may, within 6 weeks of 2nd February 1987 apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

SCHEDULE (all distances are approximate)

The highway to be stopped-up is at Cardiff in the County of South Glamorgan and is that length of Llanmaes Street which extends from its junction with Clive Street in a general easterly direction for a distance of 37 yards.
