## ROAD TRAFFIC REGULATIONS ACT 1984

*The County of Northumberland  
(Eastern Lane-West Street Link road, Berwick-upon-Tweed)  
(One Way Driving, No Entry, No Waiting and  
Weight Restriction) Order 1987*

Notice is hereby given that The County Council have made an Order, to come into force on 13th February 1987, affecting streets in Berwick-upon-Tweed which will have the following effect:

- (a) Prohibit waiting at any time on any day on the following lengths of road:

*Eastern Lane*

1. On the west side from 3 metres south-west of the junction with the southern channel line of the Eastern Lane-West Street Link Road in a north-westerly direction for 82 metres to the junction with Marygate.

2. On the east side from 3 metres north of the junction with the northern channel line of the Eastern Lane-West Street Link Road in a north-easterly direction for 70 metres to the junction with Marygate.

*Eastern Lane-West Street Link Road.*

On both sides for its entire length.

(b) Prohibit vehicles, the gross weight of which exceeds 7.5 tonnes, from proceeding in a north-westerly direction on the Eastern Lane-West Street Link Road.

(c) Prohibit vehicles from entering Eastern Lane from its junction with Marygate.

(d) Prohibits any vehicle from proceeding south on Eastern Lane from its junction with Marygate south for a distance of 30 metres.

Exemptions will be included in the Order for certain necessary purposes.

Full details are included in the Order which, together with a map showing the proposals and a statement of the Council's reasons for making the Order, may be examined at the offices of the Borough Secretary, Berwick-upon-Tweed Borough Council, Council Offices, Wallace Green, Berwick-upon-Tweed and at the address shown below during normal office hours until 20th March 1987. If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984 or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order, you may within 6 weeks from 5th February 1987 apply to the High Court for that purpose.

*The County of Northumberland (Laburnum Terrace, Redburn)  
(Speed Restriction) Order 1987*

Notice is hereby given that the County Council have made an Order under sections 84, 85(2), 86, 87 and Schedule 6 and Part III of Schedule 9 of the Road Traffic Regulation Act 1984.

The effect of this Order, which comes into operation on 13th February 1987, is to extend the 30 m.p.h. restriction from its existing termination point at the eastern end of Laburnum Terrace in an easterly direction for a distance of approximately 140 metres to a point approximately 45 metres east of the playing field entrance.

Exceptions are included in the Order for certain necessary purposes.

Full details are included in the Order which, together with a map showing the proposals and a statement of the Council's reasons for making the Order, may be examined at the offices of the Chief Executive, Tynedale District Council, Hexham House, Hexham NE46 3NH and at the address shown below during normal office hours until 20th March 1987.

*The County of Northumberland (A695, Hillside Road-Eastwood Grange, Hexham) (De-Restriction) Order 1987*

*The County of Northumberland (Extension to Burdon Avenue, Nelson Village) (One-Way Traffic) Order 1987*

Notice is hereby given that Northumberland County Council have made an Order, to come into operation on 9th February 1987, which affects the extension to Burdon Avenue, Nelson Village.

No person will be allowed to cause or permit any vehicle to proceed in an easterly direction along the extension to Burdon Avenue from 80 metres east of its junction with Nelson Avenue to its junction with Old Craw Hall Lane.

*The County of Northumberland (High Greens, Castlegate and Bell Tower Place, Berwick-upon-Tweed)  
(Waiting Restrictions) Order 1987*

Notice is hereby given that Northumberland County Council have made an Order which will come into operation on 6th March 1987 and will have the following effect:

*No waiting at any time restriction at the following locations in Berwick-upon-Tweed.*

1 *Castlegate*

On the eastern side, from a point 7 metres south of the southern channel line of High Greens in a southerly direction for a distance of 8 metres.

2 *High Greens*

(i) On the north side, from a point 15 metres east of the eastern channel line of Castlegate in an easterly direction for a distance of 48 metres.

(ii) On the north side, for a distance of 10 metres on either side of the junction with Bell Tower Place.

(iii) On the south side, from a point 15 metres east of the eastern channel line of Castlegate in an easterly direction for a distance of 43 metres.

3 *Bell Tower Place*

On both sides, for a distance of 5 metres from the junction of High Greens.
