TOWN AND COUNTRY PLANNING ACT 1971

The Secretary of State for Transport hereby gives notice that he has made an Order under section 209 of the above Act entitled "The Stopping Up of Highways (County of Avon) No. SW 2) Order 1987" authorising the stopping up of lengths of Kingsmead East and Milk Street, Bath and requiring the provision of a new highway mantainable at the public expense.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the above Act or that any requirement of that Act or of any regulation made thereunder has not been complied with in relation to the Order, may, within 6 weeks of 26th February 1987 apply to the High Court for the suspension of quashing of the Order or of any provision contained therein.

TOWN AND COUNTRY PLANNING ACT 1971

The Secretary of State for Transport hereby gives notice that he proposes to make an Order under section 209 of the above Act to authorise the stopping up of a rectangular area of highway land at Lower Tadmarton in the District of Cherwell, Oxon. This will enable development, consisting of the insertion of a tie rod and the construction of a buttress to support the front external wall, to be carried out at Perkins, Hollow Road, in accordance with planning permission granted by Cherwell District Council under Part III of the said Act.

During 28 days from 26th February 1987 copies of the draft Order and relevant plan may be inspected at all reasonable hours at the Cherwell District Council Offices, Bodicote House, Bodicote, Banbury, Oxon, and at the address of the Clerk to the Tadmarton Parish Council, Main Road, Upper Tadmarton, Oxon. TOWN AND COUNTY PLANNING ACT 1971

The Secretary of State for Transport hereby gives notice that on the application of the Bolsover District Council, he proposes to make an Order under section 212 of the above Act to provide for the extinguishment of any right which persons may have to use vehicles on lengths of Vicar Lane, Tibshelf.

The proposed Order will contain provisions for permitting the use of that highway by vehicles being used:

- (a) for police, ambulance or fire brigade purposes;
- (b) in connection with the laying, erection, inspection, maintenance, alteration, repair, renewal or removal in or near the said length of highway of any sewer, main, pipe, conduit, wire, cable or other apparatus tor the supply of gas, water, electricity or of any telecommunication apparatus as defined in Schedule 2 to the Telecommunications Act 1984.
