- (g) All Notices in the Public Notices section will be subject to a set fee of £70.27 (£61.10 + VAT) to be prepaid at time of insertion. For each additional 5 lines or under, above 35 lines, a further £7.90 will be charged plus VAT.
- (h) All other Notices or Advertisements, including Applications to Parliament, will be charged by the number of lines appearing in plain matter in the type of the Gazette:

If not exceeding 10 lines of printed matter: $\pounds 25.59$ ($\pounds 22.25 + VAT$). For each additional 5 lines or under: $\pounds 9.09$ ($\pounds 7.90 + VAT$).
