HIGHWAYS ACT 1980

The Secretary of State for Transport hereby gives Notice that he has confirmed the following Orders and Schemes made by the former West Midlands County Council:

- (1) The County Council of West Midlands (Black Country Route—Owen Road to M6 Motorway Junction 10) (A454 Classified Road) (Side Roads and Other Works) Order 1985; and

The County Council of West Midlands (Black Country Route—Coseley Road to the Keyway) (A463, A4039 Classified Roads) (Side Roads and Other Works) Order 1985 the above Orders made, respectively, under sections 14 and 125 of the Highways Act 1980 and which, as confirmed authorise the Walsall Metropolitan Borough Council as successors to the former County Council:

- (a) to improve, raise, lower or otherwise alter highways;
 - (b) to stop up highways;
 - (c) to construct new highways;
 - (d) to stop up private means of access to premises; and
 - (e) to provide new means of access to premises.
- (2) The County Council of West Midlands (M6 Motorway Junction 10) (Side Roads) Order 1985; and
The County Council of West Midlands (M6 Motorway Junction 10) (Supplementary Side Roads) Order 1985
