The effect of the designation of the Conservation Area may be summarised as follows:

- (1) Where any application for planning permission for development of land in or adjacent to the Conservation Area is made to the Council and the development would, in the opinion of the Council, affect the character or appearance of the Conservation Area, the application will be subject to the special procedure for publicity in section 28 of the Town and Country Planning Act 1971 as amended.
- (2) Anyone wishing to demolish a building or part of a building situate within the Conservation Area must first apply for consent to demolition to the Council. Such an application must be made separately and not as part of an application for planning permission for redevelopment of the site. Some buildings may be exempt from this requirement.
- (3) Anyone wishing to cut down, top, lop, or uproot a tree situate within the Conservation Area must give 6 weeks prior notice of his intention to the Council. This requirement does not apply to trees already subject to a tree preservation order but the restrictions contained in the tree preservation order continue to apply to such trees.
