AVON COUNTY COUNCIL*County of Avon (Knightwood Road, Stoke Gifford, District of Northavon) (Prohibition of Driving) Order 1987*

Notice is hereby given that on 31st March 1987 the County Council of Avon made an Order under sections 1(1) and (2) and 2(1) to (3) of the Road Traffic Regulation Act 1984, the effect of which is:
