STOKE-ON-TRENT CITY COUNCIL

City of Stoke-on-Trent (Order No. 41) Smoke Control Order 1986

Notice is hereby given that the Council of the City of Stoke-on-Trent in exercise of the powers conferred on them by section 11 of the above-mentioned Act have made an Order entitled "The City of Stoke-on-Trent (Order No. 41) Smoke Control Order 1986" declaring the area described in the Schedule hereto to be a Smoke Control Area.

The effect of the proposed Order will be that subject to the exemptions provided by the Order and by virtue of section 11(2) of the Act, if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the smoke control area, the occupier of that building shall be guilty of an offence and liable on summary conviction to a fine not exceeding £400 unless it is proved that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

The Order will come into operation on 1st November 1987.
