- 57. Footpath No. 80 which runs from its junction with footpath Nos. 79 and 81 north-west of Bank House Farm in a south-easterly direction for a distance of about 330 metres to its junction with footpath Nos. 88 and 94 at Bank House Farm.
- 58. Footpath No. 88 which runs from its junction with footpath Nos. 80 and 94 at Bank House Farm in a generally south-easterly direction for a distance of about 120 metres to its junction with footpath Nos. 89 and 91.
- 59. Footpath No. 89 which runs from its junction with footpath Nos. 88 and 91 south-east of Bank House Farm in a north-easterly direction for a distance of about 50 metres to its junction with footpath No. 90.
- 60. Footpath No. 95 which runs from its junction with footpath Nos. 75 and 77 north-west of Great Boys Farm in a north-easterly direction for a distance of about 210 metres to its junction with footpath Nos. 93 and 94.
- 61. Footpath No. 93 which runs from its junction with footpath Nos. 94 and 95 due north of Great Boys Farm in a south-easterly direction for a distance of about 155 metres to Mort Lane.
- 62. Footpath No. 81 which runs from its junction with footpath Nos. 82 and 83 in a south-easterly direction for a distance of about 280 metres to its junction with footpath Nos. 79 and 80.
- 63. Footpath No. 94 which runs from its junction with footpath Nos. 80 and 88 at Bank House Farm in a south-westerly direction for a distance of about 320 metres to its junction with footpath Nos. 93 and 95.
- 64. Footpath No. 91 which runs from its junction with footpath Nos. 88 and 89 south-east of Bank House Farm in a north-easterly direction for a distance of about 250 metres to its junction with footpath No. 92.
- 65. Part of footpath No. 92 which runs from its junction with footpath No. 91 north-east of Bank House Farm in a northerly direction for a total distance of about 240 metres to its junction with the Borough boundary, being that part which runs from its commencement for a distance of about 30 metres.
- 66. Part of bridle road No. 28 which runs from Cumbermere Lane at the junction of bridle road Nos. 38 and 42 east of Shakerley Old Hall in a north-westerly direction for a total distance of 450 metres to its junction with footpath Nos. 26 and 27, being that part which runs from a point about 130 metres from its commencement to its termination.
- 67. Part of footpath No. 116 which runs from Mort Lane just north of the Wigan to Atherton and Manchester railway in a south-easterly direction for a total distance of about 500 metres to its junction with footpath Nos. 114 and 119, being that part which runs from a point south of the railway 135 metres from its commencement to its termination.
- 68. Footpath No. 114 which runs from its junction with footpath Nos. 116 and 119 north-west of Platt's Fold in a southerly direction for a distance of about 50 metres to its junction with footpath No.
- 69. Footpath No. 108 which runs from its junction with footpath No. 114 north-west of Platt's Fold in a south-easterly direction for a distance of about 390 metres to its junction with bridle road Nos. 106 and 107.
- 70. Bridle road No. 106 which runs from its junction with bridle road No. 107 and footpath No. 108 north-east of Stone House in a southerly direction for a distance of about 70 metres to its junction with bridle road No. 102 and footpath No. 100.
- 71. Bridle road No. 102 which runs from its junction with bridle road No. 106 and footpath No. 100 south-east of Stone House in a generally southerly direction for a distance of 90 metres to its junction with bridle road No. 99 and footpath No. 101.
- 72. Footpath No. 101 which runs from its junction with bridle road Nos. 99 and 102 north of Turncroft in a southerly direction for a distance of 70 metres to its junction with footpath Nos. 105 and 133
- 73. Rights of way, comprising footpath Nos. 133 and 134 which run coincident with Sheep Lane from its junction with footpath Nos. 101 and 105 at Turncroft in a generally south-easterly direction for a total distance of about 640 metres to Bridgewater Road, being that part of footpath No. 134 which runs from its commencement for a distance of about 295 metres.
- 74. Footpath No. 119 which runs from its junction with footpath Nos. 114 and 116 north-west of Platt's Fold in a generally south-easterly direction for a distance of about 440 metres to its junction with footpath Nos. 120 and 122 at the site of the former Common Head Farm.
- 75. Footpath No. 122 which runs from its junction with footpath Nos. 119 and 120 north-east of Platt's Fold in an easterly direction for a distance of about 70 metres to its junction with footpath Nos. 124 and 125.

- 76. Part of footpath No. 124 which runs from its junction with footpath Nos. 122 and 125 due north of New Manchester in a southerly direction for a total distance of about 260 metres to its junction with footpath Nos. 121 and 123 at the north end of Lower New Row, being that part which runs from its commencement for a distance of 240 metres.
- 77. Bridle road No. 107 which runs from its junction with bridle road No. 106 and footpath No. 108 north-east of Stone House in a south-easterly direction for a distance of about 120 metres to its junction with bridle road No. 110 and footpath No. 109.
- 78. Footpath No. 109 which runs from its junction with bridle road Nos. 107 and 110 north-east of Turncroft in a northerly then north-easterly direction via Platt's Fold for a distance of about 285 metres to its junction with footpath Nos. 120 and 121.
- 79. Part of footpath No. 121 which runs from its junction with footpath Nos. 109 and 120 east of Platt's Fold in a south-easterly direction for a total distance of about 190 metres to its junction with footpath Nos. 123 and 124 to the north-west of New Manchester being that part which runs from its commencement for a distance of 175 metres.
- 80. Footpath No. 100 which runs from its junction with bridle road Nos. 102 and 106 east of Stone House in a generally westerly direction for a distance of about 140 metres to its junction with footpath Nos. 96 and 97.
- 81. Part of footpath No. 96 which runs from its junction with footpath Nos. 97 and 100 south of Stone House in a westerly direction for a total distance of about 550 metres to Mort Lane, being that part which runs from its commencement for a distance of about 220 metres.
- 82. Bridle road No. 99 which runs from its junction with bridle road No. 102 and footpath No. 101 south of Stone House in a northwesterly direction for a distance of about 110 metres to its junction with bridle road No. 98 and footpath No. 97.
- 83. Part of bridle road No. 98 which runs from its junction with bridle road No. 99 and footpath No. 97 south of Stone House in a westerly direction for a total distance of 390 metres to Sale Lane, being that part which runs from its commencement for a distance of 150 metres.
- 84. Footpath No. 105 which runs from its junction with footpath Nos. 101 and 133 south of Turncroft in a easterly then north-easterly direction for a distance of about 365 metres to its junction with bridle road Nos. 113 and 115.
- 85. Part of bridle road No. 115 which runs from its junction with bridle road No. 113 and footpath No. 105 east of Turncroft in a south-easterly direction for a total distance of about 225 metres to City Road, being that part which runs from its commencement for a distance of about 220 metres.
- 86. Part of footpath No. 103 which runs from its junction with footpath Nos. 133 and 134 south of Turncroft in a westerly direction for a total distance of about 480 metres to Sale Lane, being that part which runs from its commencement for a distance of about 175 metres.
- 87. Footpath No. 120 which runs from its junction with footpath Nos. 119 and 122 north-east of Platt's Fold in a south-westerly direction for a distance of about 195 metres to its junction with footpath Nos. 109 and 121.
- 88. Footpath No. 125 which runs from its junction with footpath Nos. 122 and 124 due north of New Manchester in a northerly direction for a distance of about 95 metres to its junction with footpath Nos. 126, 127 and 130.
- 89. Footpath No. 127 which runs from its junction whih footpath Nos. 125, 126 and 130 south of the Sycamores Sewage Works in a northerly direction for a distance of about 150 metres to its junction with footpath No. 42 at the Borough boundary.
- 90. Bridle road No. 110 which runs from its junction with bridle road No. 107 and footpath No. 109 south-west of Platt's Fold in a south-easterly direction for a distance of about 50 metres to its junction with bridle road No. 112 and footpath No. 111.
- 91. Bridle road No. 112 and footpath No. 111 which run coincidentally from their junction with bridle road No. 110 south of Platt's Fold in a south-easterly direction for a distance of about 130 metres to their junction with bridle road No. 113.
- 92. Bridle road No. 113 which runs from its junction with bridle road No. 112 and footpath No. 111 south of Platt's Fold in a southeasterly direction for a distance of about 30 metres to its junction with bridle road No. 115 and footpath No. 105.
- 93. Footpath No. 97 which runs from its junction with footpath Nos. 96 and 100 near Stone House in a south-easterly direction for a distance of about 45 metres to its junction with bridle road Nos. 98 and 99.
