

## DEVON COUNTY COUNCIL

*The County of Devon (Various Streets, Kenton) (Prohibition of Waiting) (Comprehensive) Order 1987*

Notice is hereby given that Devon County Council proposes to make an Order under the Road Traffic Regulation Act 1984.

When the Order comes into effect you will not be allowed to leave your vehicle at any time in the following length of road:

*High Street*, Kenton, south-west side from a point 46 metres south-east of its junction with Torrington Place south-westwards for a distance of 53 metres.

Exemptions in the Order permit waiting for the purpose of boarding and alighting, loading and unloading, post office services, maintenance of the road, supply of gas, water and electricity, pursuance of statutory powers of duties. The statutory exemptions for disabled person's vehicles are included.

Details are contained in the draft Order which together with a map showing the affected length of road and the statement of the Council's reasons for proposing to make the Order may be examined during usual office hours at the offices of Teignbridge District Council, Kingsteignton Road, Newton Abbot, or at the Manor House, Dawlish.

## MID GLAMORGAN COUNTY COUNCIL

*The Mid Glamorgan County Council (Graigside, Nantgarw) (Prohibition of Entry) Order 1987*

Notice is hereby given that the Mid Glamorgan County Council propose to make an Order under sections 1 and 2 of the Road Traffic Regulation Act 1984 the effect of which will be to prohibit any vehicle proceeding in the Nantgarw to Penrhos Principal Road, Route A468 from entering Graigside, Nantgarw to a point approximately 10 metres north of the northern boundary of the property known as No. 1 Graigside, Nantgarw, unless requiring access to premises on or adjacent to the road.
