The (A57) Liverpool-Skegness Trunk Road (South Yorkshire/Nottinghamshire County Boundary-A1) (24-hour Main Carriageway Clearway) Order 1987.

The Secretary of State for Transport hereby gives notice that he has made an Order under sections 1(1) and (2), 2(1) and (2), 3(2) and 4(1) of the Road Traffic Regulation Act 1984 on the (A57) Liverpool-Skegness Trunk Road.

The effect of the Order, which comes into force on 1st May 1987, is to impose 24-hour main carriageway clearway regulations on the length of the (A57) Trunk Road described in the Schedule below.

Exemptions will be provided in the Order to enable a vehicle to wait for so long as may be necessary to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein.
