

## NOTICE OF PROPOSALS OF THE THAMES WATER AUTHORITY TO ABSTRACT WATER

Notice is hereby given, that the Thames Water Authority have made proposals for the variation of licence to abstract water No. 28/39/23/8 which authorises abstraction from Greys Road Pumping Station, Henley.

The Authority propose to increase hourly and daily abstraction from 40,000 gallons and 850,000 gallons to 42,000 gallons and 1,000,000 gallons respectively. However, the present annual quantity authorised to be abstracted, 310 million gallons, will remain unchanged. The Authority also propose to make minor amendments to the licence with regard to metrication and dates.
