

Angouleme Way to a point 15 metres east of the easterly kerbline of Albert Street.

North east side from its junction with Angouleme Way to its junction with The Rock.

Bond Street, Bury, both sides between its junctions with Rochdale Road and Queen Street.

Slip Road between Bond Street and Rochdale Road, Bury, both sides for its entire length.

Heywood Street, Bury, west side between its junctions with Rochdale Road and Mason Street.

East side between its junctions with Rochdale Road and Ormond Street.

Pimhole Road, Bury, both sides from its junction with Rochdale Road to a point 15 metres south of the southerly kerbline of Rochdale Road.

Tinline Street, Bury, both sides from its junction with Rochdale Road to a point 10 metres south of the southerly kerbline of Rochdale Road.

(iii) *Prohibition of Entry*

Slip Road between Bond Street and Rochdale Road, Bury, entry prohibited from Rochdale Road.

(iv) *Revocation of existing restrictions where these are in conflict with the above proposals*

Exceptions have been included in the Order to permit waiting for boarding or alighting, loading or unloading (except where specifically restricted), funerals, building operations or work on or under the lengths of road referred to in the paragraph above. Disabled persons' vehicles bearing a disabled persons' badge and a parking disc will be allowed to wait for up to two hours, return prohibited within one hour in the length of road referred to in the paragraph above.

Proposed changes to Parking Places in Belsize Park Gardens, Briardale Gardens, Frognal Lane, Howitt Road, Savernake Road and Westbere Road.

Notice is hereby given, that the Council of the London Borough of Camden (The Council) proposes to make an order to be entitled and the Camden (Free Parking Place) (Disabled Persons) (No.) Order 198 under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by section 8 of and Part I of Schedule 5 to the Local Government Act 1985.

2. The general effect of the Order will be to:

(a) Revoke a Disabled Persons parking place in Howitt Road and designate Disabled Persons parking places in Belsize Park Gardens, Briardale Gardens, Frognal Lane, Howitt Road, Savernake Road and Westbere Road.

(b) Provide that the vehicles which may be left in the disabled persons parking places shall be those displaying in the relevant position a disabled person's badge issued in accordance with the provisions of the Disabled Persons (Badges for Motor Vehicles) Regulations 1975 or 1982.

(c) Provide that the disabled persons parking places will operate between 8.30 a.m. and 6.30 p.m. on Mondays to Fridays inclusive and between 8.30 a.m. and 1.30 p.m. on Saturdays (Christmas Day, Good Friday and Bank Holidays excepted).
