Any claim must be served on the Council at its above address within a period of 6 months from 28th April 1987, unless the period is extended in any particular case by the Secretary of State.

CLEAN AIR ACT

BATH CITY COUNCIL

The Bath City Council (No. 6) Smoke Control Order 1987

BERWICK-UPON-TWEED

Berwick-upon-Tweed (Off-Street Parking Places) (Amendment) Order 1987

The Borough of Bournemouth (Prohibition and Restriction of Waiting) Order 1981 (Variation) (No. 2) Order 1987

The Borough of Bournemouth (Norwich Road) (Prohibition of Entry) Order 1987

Notice is hereby given that the Bournemouth Borough Council, acting as agent of the Dorset County Council pursuant to arrangements made under section 101 of the Local Government Act 1972 with the said County Council, in exercise of its powers under section 1(1) and (2), 2(1) to (3), 4(2) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, propose to make the above Orders.

extended centre line of Priestley Road;
(c) prohibited at any time, With No Loading/Unloading At Any Time, on the eastern and northern sides of Avenue Lane from its northern junction with Avenue Road in a southerly and easterly direction for 90 metres to include the turning head at its

eastern end;

(d) prohibited at any time, With No Loading/Unloading At Any Time, on the southern side of Avenue Road from Avenue

Lane in a westerly direction to The Triangle;

(e) prohibited at any time on the south-eastern side of Beechey Road from Lansdowne Road to a point 10 metres north-east of Wellington Road, on the north-western side of the road for 9 metres from Lansdowne Road, and on the northwestern side of the road from a point 10 metres south-west to a point 15 metres north-east of Wellington Road;

(h) prohibited at any time on the north-western side of Bennett Road from a point 18 metres south-west of the centre line of Chatsworth Road to Richmond Park Road, on the south-eastern side of the road from a point 10 metres southwest to a point 17 metres north-east of the centre line of Shaftesbury Road, and on the south-east side of the road from Richmond Park Road for 31 metres in a south-westerly

(i) prohibited at any time on the southern side of Richmond Park Road from a point 32 metres west to a point 82 metres east of the centre line of Bennett Road;

(j) prohibited at any time on the western side of Oak Road for 5 metres from Richmond Park Road, and on the eastern side of the road for 10 metres from Richmond Park Road;

(k) prohibited between 8 a.m. and 6 p.m. Monday to Friday on the south-eastern side of Bennett Road from a point 17 metres north-east of the centre line of Shaftesbury Road for 68 metres in a north-easterly direction;

(I) prohibited at any time on the north-eastern side of Shaftesbury Road for 38 metres from Bennett Road, and on the south-western side of the road for 33 metres from Bennett Road:

(m) prohibited between 8 a.m. and 6 p.m. on the eastern/northern side of Beswick Avenue from a point 9 metres north of Columbia Road for 99 metres in a northerly/westerly direction, and on the western/southern side of the road from a point 86 metres north of Columbia northerly/westerly direction for 14 metres; Road

(n) prohibited at any time on the eastern side of Sea Road from Hawkwood Road in a southerly direction to a point 15

metres south of the centre line of Westby Road;

- (o) prohibited between 10 a.m. and 7 p.m. on the southern side of Cecil Road for 10 metres from Sea Road;
- (p) prohibited at any time on the southern side of Drummond Road from Knole Road for 90 metres in an easterly direction, and on the northern side of the road from Knole Road for 15 metres in an easterly direction;
- (q) prohibited at any time on both sides of Knole Road for 9 metres in a northerly direction from Drummond Road, on the eastern side of the road for 10 metres in a southerly direction from Drummond Road, and on the western side of the road for 7 metres from Southcote Road in a southerly direction;

- (w) prohibited at any time on the western side of Heron Court Road from a point 18 metres north of Alma Road in a northerly direction to a point 17 metres north of the centre line of Fitzharris Avenue, and on the eastern side of the road from a point 11 metres south to a point 11 metres north of the centre line of Fitzharris Avenue;
- (x) prohibited at any time on the northern side of Fitzharris Avenue from a point 11 metres east to a point 17 metres west of the centre line of Heron Court Road, and on the southern side of the road from a point 11 metres west to a point 21 metres east of the centre line of Heron Court Road;
- (y) prohibited at any time on the northern side of Hillcrest Road from Wimborne Road for 95 metres in an easterly direction;
- (z) prohibited at any time on the eastern side of Wimborne Road from the centre line of Hillcrest Road for 20 metres in a northerly direction;
- (aa) prohibited at any time on both sides of Hillview Road for 6 metres from Redhill Drive;
- (bb) prohibited at any time on the western side of Redhill Drive from a point 38 metres south to a point 21 metres north of the centre line of Hillview Road, and on the eastern side of the road from a point 18 metres north to a point 28 metres south of the extended centre line of Hillview Road;
- (cc) prohibited at any time, with no loading/unloading at any time, on the northern side of Hinton Road between St. Peter's Road and Old Christchurch Road, and on the southern side of the road from a point opposite the western side of St. Peter's Road in an easterly direction for 23 metres;

- (ee) prohibited at any time on the northern side of Braidley Road from a point 30 metres west of Bodorgen Road in a westerly direction to a point 14 metres west of the centre line of Merlewood Close;
- (ff) prohibited at any time on the western and northern sides of Merlewood Close for its entire length, on the eastern side of the road for 21 metres from its northern end, including all sides of the turning head, and on the eastern side of the road from Braidley Road for 10 metres;
- (gg) limited to 2 hours, return prohibtied within 2 hours, between 10 a.m. and 7 p.m. on the northern side of Northcote Road from a point 20 metres east of Holdenhurst Road in an easterly direction for 100 metres;
- (hh) prohibited at any time on the north-western side of Oswald Close for its entire length including the head of the road, and on the south-eastern side of the road from a point 45 metres north-east of Oswald Road in a northerly direction to the head of the road;

- (kk) prohibited at any time on the eastern side of School Lane from a point 20 metres south of Wimborne Road service road in a southerly direction for 32 metres, and on the western side of the road from a point 36 metres south of Wimborne Road for 4 metres in a southerly direction;
- (ll) prohibited at any time on the southern side and western end of Smithfield Place for its entire length, and on the northern side of the road for 12 metres from its western end;
- (mm) prohibited at any time on the western side of Wimborne Road from a point 8 metres south to a point 8 metres north of Smithfield Place:
- (nn) prohibited between 7 a.m. and 10 p.m. on the northeastern side of Victoria Place from Spring Road in a northwesterly direction to Stanley Road;
- (00) prohibited at any time on the southern side of Windham Road from a point 46 metres east of Cleveland Road for 105 metres in an easterly direction;
- (pp) prohibited at any time on the western side of Austin Close from a point 9 metres south of Windham Road for 60 metres in southerly/easterly/northerly direction to include the turning head:
- (qq) prohibited at any time on the south-western side of Boscombe Grove Road for 5 metres from Windham Road, and on the north-eastern side of the road for 10 metres from Windham Road;
- (rr) prohibited between 8 a.m. and 7 p.m. Monday to Friday on the eastern side of Wolverton Road from a point 9 metres north of Christchurch Road for 70 metres in a northerly direction:
- (ss) prohibited at any time on the southern side of Ensbury Park Road from a point 23 metres east of the extended centre line of Cherries Drive for 65 metres in an easterly direction;
- (tt) prohibited at any time on all sides of Oxford Close including the turning head;
- (uu) prohibited between 10 a.m. and 10 p.m. on the southern side of Portchester Place for 10 metres from Holdenhurst Road, and on the northern side of the road for 5 metres from Holdenhurst Road;
- (vv) limited to 2 hours, return prohibited within 2 hours, between 10 a.m. and 6 p.m. Monday to Saturday on both sides of the north-western arm of Porchester Place from a point 100 metres west of Holdenhurst Road in a westerly direction to its western extremity, and on the southern side of the road from a point 136 metres west of Holdenhurst Road for 25 metres in a westerly direction;
- (ww) derestricted on the northern side of Methuen Close from a point 5 metres west of Holdenhurst Road for 42 metres in a westerly direction;
- (xx) derestricted on the northern side of Lowther Gardens from a point 5 metres west of Holdenhurst Road for 15 metres in a westerly direction, and from a point 52 metres west of Holdenhurst Road for 10 metres in a westerly direction;
- (yy) prohibited between 8 a.m. and 6 p.m. Monday to Saturday on the southern side of Stewart Close from a point 10 metres east of Holdenhurst Road for 62 metres in a westerly direction;
- (22) derestricted on the southern side of Shelbourne Close from a point 17 metres east of its western extremity for 13 metres in an easterly direction, and on the northern side of the road from a point 24 metres east of its western extremity for 6 metres in an easterly direction;
- (aaa) derestricted on the northern side of Capstone Place from a point 47 metres east of Holdenhurst Road in an easterly direction for 20 metres;
- (bbb) prohibited at any time, with no loading/unloading at any time, on the northern side of Old Christchurch Road from Yelverton Road for 80 metres in an easterly direction.
- (ccc) Prohibited at any time on the north-western side of Holdenhurst Road from a point 64 metres south-west of St. Paul's Road for 31 metres in a south-westerly direction.
- (B) Entry will be prohibited into that section of Norwich Road between Upper Norwich Road and Norwich Avenue, from Upper Norwich Road and the remaining section of Norwich Road.

In so far as the waiting restrictions are concerned, exceptions will permit waiting for the purposes of picking up and setting down passengers, loading or unloading goods and, where necessary, in connection with the maintenance of the roads and the supply of gas, electricity and water.

The Borough of Bournemouth (Street Parking Places) Order 1974 (Variation) (No. 1) Order 1987
