Notice is hereby given that the Southend-on-Sea Borough Council propose to make an Order under sections 1 (1) and (2), 2 (1) to (3) and 4 (2) of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act the effect of which will be to prohibit waiting in:

(a) *Glendale Gardens*, north side for a distance of 15 metres at the following junctions, Elm Road, Lymington Avenue, Southsea Avenue, Fairleigh Drive and Westleigh Avenue.

(b) in the following roads, both sides for a distance of 15 metres from their junctions with Glendale Gardens; Fairleigh Drive, Leighville Grove, Grange Road, Marine Avenue and Westcliff Drive.
